USGA Rules Govern All Play

Local Rules

- Embedded Ball rule is in effect anywhere in the general area (Rule 16.3).
- E-5 Alternative to Stroke and Distance for Lost Ball or Ball Out of Bounds.
- The boundary of the Penalty Area is determined by red or yellow lines. Red stakes may also identify Penalty Areas that border cart paths. In the absence of a red line, the edge of the cart path nearest the Penalty Area will determine where the Penalty Area begins.

- Ground under repair is defined by white lines.
- Out of bounds is determined by white stakes. In absence of white stakes, out of bounds will be determined by golf course property.
- Please take relief from staked trees as an immovable obstruction, except in a Penalty Area.
- Stones in bunkers are movable obstructions: (Rule 24-1) applies.
- Drop zones are provided on #3, #11, & #14.
- Sprinkler heads- Local Rule Appendix 1-4 applies: Relief without penalty when sprinkler head(s) are within 2 club lengths of the putting surface and the ball lies within 2 club lengths of the sprinkler heads.
